This Privacy Policy describes how your personal information is collected, used, and shared when you visit or make a purchase from the <https://parisnftconference.com> ("Website"). This Policy is part of our Terms&Conditions of Sales and is incorporated by reference. We encourage you to read it carefully. By using the Website, you agree to be legally bound by the following:

PERSONAL INFORMATION WE COLLECT

When you visit the Website, we automatically collect information about your device, including information about your web browser, IP address, time zone, and some of the cookies that are installed on your device. Additionally, as you browse the Website, we collect information about the individual web pages that you view, what websites or search terms referred you to the Website, and information about how you interact with the Website. We refer to this automatically-collected information as "Device Information."

We collect Device Information using the following technologies:

- "Cookies" are data files that are placed on your device or computer and often include an anonymous unique identifier. For more information about cookies, you may refer to our Cookies Policy.
- "Log files" track actions occurring on the Site, and collect data including your IP address, browser type, Internet service provider, referring/exit pages, and date/time stamps.
- "Web beacons," "tags," and "pixels" are electronic files used to record information about how you browse the Site.

Additionally when you make a purchase or attempt to make a purchase through the Website, we collect certain information from you, including your name, date of birth, gender, billing address, shipping address, payment information (including credit card numbers), email address, and phone number as well as any information you voluntarily provide to us. We refer to this information as "Order Information".

We use and/or store your the data : (a) to verify your identity when attending the event; (b) to contact you regarding your purchase on the Website (technical support emails), send emails with our newsletters, announcements, and other offers (marketing emails); and (c) to comply with our legal obligations.

We collect information to provide better services to the Attendees of our event and to inform existing and potential attendees of events, training, workshops or support services that might be of interest. For instance, when you register to attend our events, receive consultancy support, or sign up to our mailing list, we will ask for personal and business information, such as your name, company name, email address and telephone number. The information we request is dependent on the service you receive.

We use the information we collect from all of our services for administrative purposes and for all of the purposes falling within the scope of the non-profit Universal Crypto Education included but not limited to educational, humanitarian etc... and the legitimate non-profit purposes, to provide, maintain, protect and improve our activities, to develop new ones, and to protect Universal Crypto Education

We will use your email address to inform you about our services and request feedback on the Event.

We will ask for your consent before using information for a purpose other than those that are set out in this Privacy Policy.

We may share personal information with other companies and individuals within UCE, and with selected third parties such as event hosts, business partners or suppliers for the performance of any contract we enter into with them or you.

We may share your information with analytics and search engine providers that assist us in the improvement and optimisation of the Website.

We may disclose your personal information if we are compelled by law to do so, or to protect the rights and property of the Organiser.

You have the right to ask us not to contact you for marketing purposes and/or to withdraw your consent to direct marketing at any time. You can exercise this right at any time after giving consent by contacting us at contact@parisnftconference.com
